

Forest-related economic activity in Prentiss County during 2013 generated 784 jobs and more than \$30.5 million in income. That's about 8%of jobs and 9%of income in the county. Employment is the number of full- and part-time jobs in all sectors of the economy. Income is salaries and wages paid to employees.

#### TOTAL OUTPUT AND VALUE ADDED IMPACTS

Forestry and the forest products industry generated more than \$114 million, or about 7.8% of economic output, in Prentiss County. Forest-related value added amounted to nearly \$38 million, or about 6.6% of all value added in the county. The value of all goods and services produced is defined as total output. Value added is a portion of total output and represents the creation of new wealth.

#### **TAX IMPACTS**

Forest-related economic activity contributed an estimated \$8.4 million in tax revenue for federal, state, and local governments. This total includes tax revenue of \$5.7 million for federal and \$2.7 million for state and local governments.

### PRENTISS

Forestry and forest products are important to Prentiss County's economy. They contribute to many sectors of the economy. The economic contribution of forest-related sectors and their impacts on other sectors can be estimated using input-output analysis. Using 2013 data, this study estimates the total economic contribution of forestry and the forest products industry to Prentiss County, Mississippi.
